REF: Concern on CSW 59 procedure

Dear Luiza:

Please receive our warmest greetings on behalf of the women and feminists of Latin America and the Caribbean through the Committee of NGOs on the Status of Women from Latin America and the Caribbean - CoNGO CSW LAC. We are writing to you to express our concern, and that of the women's organizations of the region, regarding the adopted procedure for the elaboration of the Declaration of the 59th Session of the Commission on the Status of Women, which will take place on 9-20 March 2015 in New York.

As this year marks the 20th anniversary of the IV World Conference on Women held in Beijing, the international community, especially women and feminists, expect this session with great interest because it represents the opportunity to reaffirm the commitment assumed in Beijing, promote the acceleration of its achievements and to readdress the new challenges ahead, which will be linked to the new Post 2015 Development Agenda.

The participation of the civil society and the incorporation of its perspective in this process is key and enriching. Therefore, we are deeply concerned because the procedures that traditionally governed the CSW sessions were changed and now a Declaration is previously considered before its approval at the beginning of CSW 59. This modality overtly leaves aside the participation of civil society organizations, which for decades have been working and providing input to the CSW documents and resolutions.

Limiting the participation of our civil society representatives and organisations impedes the inclusion of our voice as experts, champions and defenders of women's & girls rights and gender equality in these current discussions of delegations. This is a regrettable precedent in the history of CSW which contradicts the UN policies and particularly those of UN WOMEN, which encourages the participation of civil society at all instances, instead of restricting it.

Incorporating the perspective and diversity of women's and feminists' organizations prevailed at the IV World Conference on Women in Beijing and this was reflected in the Platform of Action which is now celebrating 20 years. It was thanks to the presence and pressure of the women's and feminists' organizations that the world advanced in the gender equality agenda and the rights of women. Therefore, we consider the absence of civil society representatives in the discussion on the CSW 59 Declaration a serious step back, which should not set a precedent. The lack of transparency in what will be agreed is an element that affects the validity of the Declaration.

For these reasons, we ask you to transmit our concern to UN WOMEN Executive Director Ms. Phumzile Mlambo-Ngcuka on behalf of the women's and feminists' organizations & civil society organizations from Latin America and the Caribbean.

We hope that these concerns are taken into account so the procedures are kept to guarantee the open and plural participation of all stakeholders: States, civil society and relevant others. This is critical so that transparency in decision-making is protected and prominently reflected. This is particularly important in this year when the Commission on the Status of Women honors the commitments made and agreed 20 years ago in Beijing and which have been further advanced in progressive UN sessions and summits and so that we ensure their ratification in 2015.
